Library Happenings

Usage statistics for May

- May is typically one of the 3 slowest months of the year as people are busy with graduations, weddings, and gearing up for summer.
- Website traffic more than doubled, likely due to the summer newsletter
- The free Covid-19 home test kits from MDHHS have been discontinued at libraries. MDHHS has cited funding cuts as the culprit. The library still has some kits available and will continue to distribute them until the stock is gone.
- The study rooms are now open and the library is accepting reservations for use.
- The library is selling the special Summer Reading t-shirts to the public this year. T-shirts must be prepaid and ordered by Friday, June 13th at 3pm to pick up before the Summer Reading Kick-off. We will continue to sell t-shirts at the event. The shirts are \$25.
- The Summer Reading Kick-off is scheduled for Saturday, June 21st. This year's Summer Reading theme is "Color Our World" and the library has reading programs for kids, teens, and adults. The library had a large amount of sponsors participate this year in the youth program and have lots of great prizes to give away!
- Beginning on June 1st the library has upgraded services with NewsBank and is now offering a World News collection featuring access to newspapers all over the world. Heritage Hub, a collection of obituaries and death notices is now available and great for researching family histories. Asian Life in America, Black Life in America, Hispanic Life in America and Indigenous Life in America are also included in the new upgrades.
- We are closely watching the situation with the federal budget. The Institute of Museum and Library Services (IMLS) is a federal agency that provides funding through the Museum and Library Services Act of 2018 (LSTA) to the states. The Library of Michigan uses these resources to benefit school, public, and academic libraries, as well as library users and all Michigan residents directly. The premier programs funded by LSTA resources are the Michigan eLibrary (MeL) and MeLCat, the statewide reciprocal borrowing system that allows HTPL to borrow materials from over 300 libraries statewide. In 2024, HTPL used MeLCat services almost 6,000 times. The statewide impact could be significant. On Friday, March 14, 2025, President Trump signed an Executive Order to dismantle the Institute of Museum and Library Services. On May 1st, The U.S. District Court for the District of Columbia issued a temporary restraining order to stop the dismantling of IMLS and release the funding. On May 6th, Chief Judge John J. McConnell, Jr. of the U.S. District Court for the District of Rhode Island issued a

preliminary injunction in the case of State of Rhode Island et al. v. Trump et al., halting the implementation of Executive Order 14238 as it pertains to the Institute of Museum and Library Services (IMLS), the Minority Business Development Agency (MBDA), and the Federal Mediation and Conciliation Service (FMCS). The library will continue to watch the situation and circumstances surrounding it.
