Library Happenings

Usage statistics for June

- June is typically a good month as Summer Reading kicks off
- Website traffic returned to normal after elevated numbers in May
- 94 new cards were issued, which is higher than normal and likely due to Summer Reading programs
- The free Covid-19 home test kits from MDHHS have been discontinued at libraries. MDHHS has cited funding cuts as the culprit. The library still has kits available and will continue to distribute them until the stock is gone.
- The library has Monarch habitats up and running with the first eggs and caterpillars of the season.
- The Summer Reading Kick-off was a huge success with over 300 in attendance!
- Electronics Recycling Day is scheduled for Saturday, July 26th from 10 am-12 pm.
- Staff are working on the next newsletter, scheduled to go to the printer on July 28 for an August 26th distribution date. This newsletter will cover September-December 2025.
- The library is working with Daniels and Zermack on design plans for the upcoming building expansion with the township.
- We are closely watching the situation with the federal budget. The Institute of Museum and Library Services (IMLS) is a federal agency that provides funding through the Museum and Library Services Act of 2018 (LSTA) to the states. The Library of Michigan uses these resources to benefit school, public, and academic libraries, as well as library users and all Michigan residents directly. The premier programs funded by LSTA resources are the Michigan eLibrary (MeL) and MeLCat, the statewide reciprocal borrowing system that allows HTPL to borrow materials from over 300 libraries statewide. In 2024, HTPL used MeLCat services almost 6,000 times. The statewide impact could be significant. On Friday, March 14, 2025, President Trump signed an Executive Order to dismantle the Institute of Museum and Library Services. On May 1st, The U.S. District Court for the District of Columbia issued a temporary restraining order to stop the dismantling of IMLS and release the funding. On May 6th, Chief Judge John J.

McConnell, Jr. of the U.S. District Court for the District of Rhode Island issued a preliminary injunction in the case of State of Rhode Island et al. v. Trump et al., halting the implementation of Executive Order 14238 as it pertains to the Institute of Museum and Library Services (IMLS), the Minority Business Development Agency (MBDA), and the Federal Mediation and Conciliation Service (FMCS). The library will continue to watch the situation and circumstances surrounding it.
